







# Summer school on advocacy and translation of evidence for different audiences on intersectoral action for health equity and well-being

Ljubljana, Slovenia, 6<sup>th</sup> to 7<sup>th</sup> of July 2016

#### Scope and purpose

As a WHO collaborating centre for cross-sectoral approaches to health and development, Centre for health and development Murska Sobota is organizing public health Summer schools and short trainings with the aim to increase capacity for understanding, measuring, and acting on inequalities in health and social determinants of health in central, eastern and south-eastern Europe since 2009. However, the Summer school is open to other international participants around the world as well. Important element in our work is cross-sectoral approach to health and development. This year the focus is on advocacy and translation of evidence for different audiences in order to initiate and steer the intersectoral action for health equity and well- being. 2016 edition of Summer school is organized in collaboration with partners: WHO Regions for health network, EuroHealthNet, WHO Regional Office for Europe, EVIPnet and supported by NIPH and Ministry of Health of Slovenia.

#### The objectives of this year's summer school are:

- Providing learning exchange about effective advocacy for intersectoral action for health equity and well-being
- To discuss the role of different stakeholders and organization in advocacy process.
- Providing opportunity for exchange of know-how, good practices and innovative approaches in developing and translating evidence for different audiences.

Working language will be English, since the Summer school is an international event.

There is no participation fee for Summer school, snacks, coffee breaks and lunches, as well as a tourist sightseeing of Ljubljana are covered by the organizers. Participants need to cover their accommodation and travel to the venue.






